# 1 July 2021

### **Price Schedule for Metering Services**

Under Power of Choice any new meters will be installed by the Retailers and their meter providers, the new meters installed are smart meters (Type 4). However, Essential Energy continue to be responsible for Type 5 and 6 (basic) meters reading and maintenance. The Metering services will be charged for at the AER determined rates as provided in the tables below.

#### **Meter Service Charges**

Essential Energy will charge a metering service charge for all NMI's where Essential Energy provides type 5 & 6 metering services. Charges will be charged on a 'per service' basis as a daily fixed charge. This means each unique data stream will attract a charge, for example a site with a residential anytime tariff and a controlled

load tariff will receive the applicable annual metering charge for both tariffs.

Metering services are related to the provision, operation and maintenance of type 5 and 6 metering equipment, including:

- Meter maintenance activities to inspect, and test meters;
- Meter reading the quarterly or other regular reading of type 5 & 6 meters; and
- Meter data services services for the collection, processing, storage and delivery of metering data and the management of NMI standing data in accordance with the rules.

## **Explanations and Definitions**

#### **Metering Services**

Metering services related to the provision, operation and maintenance of type 5 and 6 metering equipment, including:

- Meter provision the capital costs of purchase of metering equipment;
- Meter maintenance activities to inspect, test, maintain, repair and replace meters;
- Meter reading the quarterly or other regular reading of type 5 & 6 meters; and
- Meter data services services for the collection, processing, storage and delivery of metering data and the management of National Metering Identifier (NMI) standing data in accordance with the rules.



## Price Schedule for Metering Services – 1 July 2021

#### **Capital Recovery Charge (MSC CAPITAL)**

A capital recovery charge will apply to all sites where Essential Energy funded metering equipment to recover the costs of the regulated Metering Asset Base (MAB), i.e. the capital costs of the meter/s installed at the connection point.

The capital charge is based on the network charge structure that applied on 30 June 2015. It will remain fixed and will not change, even if our network charges change. Where a customer funded a regulated metering upgrade or switched to a competitive metering arrangement after 1 July 2015, the capital charge continues to be applied to recover our costs for previously installed regulated metering equipment funded by Essential Energy. The capital costs will

continue to be recovered until the meters are fully depreciated.

#### **Operating and Maintenance Charge (MSC MAINT)**

The operating and maintenance charge covers the ongoing operating expenditure for providing Type 5 and 6 metering services, including meter reading, testing and inspection.

A maintenance metering service charge will apply for all NMIs where we provide Type 5 and 6 metering services, i.e. where Essential Energy is nominated as Metering Coordinator, Meter Provider and Meter Data Provider for the NMI in the National Electricity Market (NEM). Where a customer has a new smart meter (Type 4) installed the operating and maintenance charge ceases.
